In consideration of Evolution Climbing & Training permitting me to make use of the facilities provided by Evolution Climbing & Training, I agree to this release of claims waiver of liability and assumption of risk.

I understand that the Trade Practices Act 1974 will imply into my contract with Evolution Climbing & Training and that I will have the benefit of certain warranties which cannot be excluded, restricted or modified and in particular warranties that:

A: The service to be supplied by Evolution Climbing & Training will be rendered with due care and skill and that any material supplied in connection with those services will be reasonably fit for the purpose for which they are supplied and

B: Where I make known to Evolution Climbing & Training, expressly or by implication the particular purpose for which I require the services or the result I desire the services to achieve, the services and any material in connection with those services will reasonably be expected to achieve the result, except where the circumstances show that I do not rely or that it is unreasonable for me to rely on those skills or judgement of Evolution Climbing & Training.

Except in the extent that I have full benefit of these warranties, I waiver any and all "other" rights and any claims resulting there from, I may now and in the future have against, and release from all liability and agree not to sue Evolution Climbing & Training and its officers, employees, instructors or agents (collectively staff) or the licensor's for any personal injury, death, property damage or loss sustained by me as a result of my participation in activities provided by Evolution Climbing & Training or taking place on property belonging to Evolution Climbing & Training, due to any cause whatsoever, including without any limitations, negligence at common law on the part of Evolution Climbing & Training its staff or the licensor's. Such risks including but not limited to personal injury, or death resulting from slips, trips, or falls while using the facilities or equipment, or failure of equipment, or injuries or death resulting from the fall of other persons or equipment who may come in contact with me or from any falls in which I or my equipment comes into contact with other persons.

I acknowledge that I have read the above Waiver of Liability relating to the facilities, staff and owners of Evolution Climbing & Training and will abide by it. I am aware that your facility in addition to usual and inherent risks has certain additional dangers which may include:

Physical exertion for which I am not prepared, the use of climbing equipment which if used incorrectly fails to perform its designed use.
